ii. Discussion of Solar Powered Water Aerator Request

We received an email from a resident concerned about mosquitos on our ponds. We do have aerators and fountains in our properties, but they are expensive.

Mr. Showe stated if we get complaints about the mosquitos and that becomes a concern there ae companies who will treat specifically for that. We find that more effective opposed to the constant expense of an aerator.

Mr. Showe stated as a CDD board member you are only required to fill out the form 1, the form 6 does not apply to you. Something new this year the form 1s are going to be electronic and you have to go to the commission on ethics and file your form 1 electronically. You do not take them to the county. You do he to take the 4 hours of ethics training this year but you do not report that until you fill our your form 1 next year.

Ms. Trucco stated some boards have asked me to send an email as a reminder that this is where you find the video links. You can go to the Florida Commission on Ethics, they are available to any member of the public, they cover the required topics and much more. The attorney general's website also has links to videos you can watch to satisfy that requirement. I'm happy to send supervisors an email with a memo of when that requirement is going to be due.
